How Curbside Drop-Off Works

- Call 682-428-2939 for an appointment.
- You'll be given a time to drop off documents at location.
- Documents will be copied and returned to taxpayer.
- You must have a Social Security Card or ITIN.
- Staff will complete the tax return on site the day the information is received.
- Taxpayers will remain in their vehicles at all times.
- Taxpayers will need to wear a mask.

Who Is NOT Eligible?

- Taxpayers who file Married Filing Separately.
- Taxpayers who have rental income.
- Taxpayers with business expenses over \$35,000.

Cómo Funciona VITA en la Acera

- Llame al 682-428-2939 para hacer una cita.
- El contribuyente tendrá una cita para entregar los documentos.
- Debe tener una tarjeta de Seguro Social o ITIN.
- Los documentos serán copiados y devueltos al contribuyente
- El personal completará la declaración de impuestos en el sitio el día que se reciba la información.
- Los contribuyentes permanecerán en sus vehículos.
- Los contribuyentes deberán usar una mascarara.

¿Quién no es elegible?

- Los contribuyentes que quieren presentar una declaración de casados por separado.
- Los contribuyentes que tienen ingresos por alquiler.
- Contribuyentes con gastos de negocio mas de \$35,000.
